

WHAT IS THE SIZE OF THE EU BUDGET?











FINANCING THE EU BUDGET

SIMPLIFICATION AND DIVERSIFICATION OF REVENUE SOURCES

Modernisation of existing Own Resources



Value Added Tax-based: simplified



Traditional Own Resources (customs duties):

lower collection costs (20% to 10%)



GNI-based contribution: smaller share

New Own Resources



Common Consolidated Corporate Tax Base

→ less likely to be retained



20% of revenues from **Emissions Trading System**



National contribution based on nonrecycled plastic packaging waste → has gained broad support by Member States

No rebates



Phasing out mechanism over five years

Higher Own Resources ceiling




From currently 1.2% of GNI to 1.29% of GNI





2020 estimated* national contributions and GNI by Member State



■ Member States benefiting from corrections ■ Member States below average EU GNI/capita


